- Earnest Money (EMD) will be opened first. If the Earnest Money is found in order, Technical Bid will be opened to assess the technical viabilities of the bidder. Based on technical evaluation/qualification, Price Bid of shortlisted qualified bidder will be opened.

- 3 Commercial Experience Criteria
 - A. For fulfilling the commercial experience criteria any one of the following documents may be considered as valid proof for meeting the criteria
 - I) Copies of relevent PO (Purchase Order) along with Invoice(s) with self certification by the bidder that supplies against the invoices covering the "similar order" have been executed to the required value.
 - II) Purchase Order copy along with Bank certificate indicating payment against the PO.
 - III) Purchase Order copy along with execution certificate by client with order value.
 - IV) In case any other document is submitted by bidder in support of execution, the same shall be properly checked by the concered officer before acceptance.
 - V) Submission of authentic document is the prime responsible of the bidder.
- 4 IN CASE BIDDER DOES NOT SUBMIT EMD AS MENTION ABOVE, THEN THE BID SHALL BE LIABLE FOR REJECTION.
- 5 The Bidder should submit up to date sale tax clearance certificate, registration number, GST clearance certificate and PAN number and related document issued by the competent authority.
- 6 The firm/bidder must submit the latest income tax clearance /exempted certificate at the time of submission of tender
- The firm/bidder willing to submit tender should produce bank solvency/guarantee certificate for the value at least 40% the estimated cost put to tender from any nationalised bank in support of his financial soundness.
- The Financial bids will be opened only of those agencies qualified to tender as per the eligibility criteria. In case the tender is not accompanied with the above and tender does not qualify as per the eligibility criteria, the tender will summarily rejected.
