1. Registered contractors, domiciled in Borum block under Papum Pare district for class-VA, IV and III & II under Itanagar Assembly Constituency only are invited to apply.
2. The Arunachal Pradesh District based Entrepreneurs and Professional ACT 2015, is only applicable.
3. NOC should be obtained from the Chairman VWSC and Panchayat leader (HGB/GP/ZPM) for availability of land at the selected site/source of the Village.
4. Payment will be made in phase manner as per the release of fund by government against the work done.
5. Department should not be held responsible for delay in payment in case of non-release of fund by the government.
6. No cost escalation shall be entertained by contractor for delay in payment due to non release of fund from government.
7. The Tender shall be submitted in two bids viz. Technical Bid and Price Bid. Each of the bids shall be placed and sealed in separate cover and mailed by registered post or by hand to the undersigned.
8. The tenderer should prepare the technical bid after visiting the actual sites of construction for which they have to contact the field officers of Executive Engineer, PHE & WS Division Itanagar, Senkhi View before collection of tender paper.
9. The Technical & financial bid shall be opened one after another and evaluated to assess the Technical viability of their proposal and financial capability of the contractors and their work experience as per the terms and conditions of bid. Based on such evaluation and after adopting the post qualification procedure, a short list of selected contractors shall be made by the competent authority of PHE & WS Department, Arunachal Pradesh. The price bid containing only the schedule of quantities with rates duly filled in by the contractors shall be opened for further evaluation.
10. The tender paper can be availed from the office of the undersigned in all working day in between 1000 hrs to 1600 hrs on payment of Rs. 1500/- (Rupees one thousand five hundred) only in the shape of D.D. (Non refundable) in favour of the undersigned, payable at State Bank of India, Itanagar.
11. Special conditions, other terms and conditions and technical details of the NIT may be seen at 'Technical Bid'.
12. The undersigned reserves the right to reject any or all tenders without assigning any reason.
13. Power of Attorney of the firm to the bidder will be rejected.
14. Drawing will be provided by the department.
15. The 5% of the tender cost shall be deducted from the running bills as community contribution due to non-release of fund by GoI and same shall be released if fund is made available to Division office.
16. The tender can be cancelled at any time/stage by the undersigned without any notice to tenderer.
