NOTICE INVITING TENDER.

The Executive Engineer, PHE & WS Division, Ziro on behalf of the Governor of Arunachal Pradesh invites sealed item Rate for Re-Tender from the eligible and approved contractors registered with CPWD/ APPWD/ MES/ BRO/ NPHC/ NEEPCO/ NBCC etc., up to 1200 hrs on **10th January 2022** for execution of Water supply schemes **under Jal Jeevan Mission (JJM)**, which will be opened on Same day (10th January'2022) at **1400 Hrs** in presence of the authorized representatives of the firms interested to be present. If the office happens to be closed on the date of opening of the tenders as specified, the bids will be opened on the next working day at the same time and venue.

1. The tender shall be submitted in two bids viz. Technical Bid and Price Bid separately for each package. Each of the bids shall be placed and sealed in separate cover and these two separate sealed bids should be further sealed in a single envelope and mailed by registered post so as to reach the undersigned or may be dropped in the tender box available in office of the undersigned on or before the stipulated date & time.
2. The tender bidder should prepare the technical bid after visiting the actual sites of construction for which they have to contact the Assistant Engineer, PHE & WS Sub Division, Yachuli before collection of tender paper. They should also visit the office of the Assistant Engineer, PHE & WS Sub-Division Yachuli to see the drawings of various components of works.
3. The Technical Bid shall be opened first and evaluated to asses the Technical and financial capability of the contractors/firms and their work experience by competent authority. Based on such evaluation and after adopting the post qualification procedure, the price bid containing only the schedule of quantities (As per PWD-8) shall be opened for further evaluation by higher competent authority.
4. The tender paper can be collected from the office of the undersigned on any working day in between 1000 hrs to 1600 hrs on payment of Rs 1500/- (Rupees One thousand Five Hundred) only in cash from cash counter of this office or in the shape of D.D. (Non refundable) in favor of the undersigned, payable at State Bank of India, Ziro up to **10.01.2022**. No tender papers shall be issued to contractors after **12.00 Noon of 10.01.2022**.
5. Earnest money @ 1% of the tender amount as indicated against each package, in the form of DCR/DD/Banker Cheque of any scheduled bank guaranteed by the Reserved Bank of India must accompany each tender, failing which the tender will be summarily rejected.
6. The undersigned reserves the right to reject any or all tenders without assigning any reason.



Terms & Conditions:

1. The interested contractors/firm willing to submit tender should be government registered contractor/firms under CPWD/ APPWD/ MES/ BRO/ NPHC/ NEEPCO etc.
2. Experience of such work execution must be substantiated with a performance report of completed or ongoing projects duly certified by the project officer. Such performance report must have the details like date of commencement, target date of completion and actual date of completion as per agreement.
3. Any firm whom a similar nature of work was awarded in the last three years and could not complete within scheduled time without justified reason authenticated by the project authority need not apply. And the firm of such contractor authorized to any other person found to have participated in the tender bidding shall not be accepted.
4. The firm must have adequate manpower of technical expertise and necessary tool and plants to handle such projects.
5. The firm must have sound financial background to complete the project even on the eventuality of unavoidable delay in payment owing to such reason as financial crunch of the client department/government. No interest will however be paid for the delay in payment.
6. The firm should be able to complete the project within **2 months** time from the date of commencement of work.
7. The firm must submit latest Income Tax clearance certificate & up to date GST return statement at the time of submission of tender.
8. The firm shall not form any joint venture or enter into association with other agency for execution of works.
9. The selected firm on acceptance of tender shall have to pay security deposit amounting to 10 (ten) percent of the cost of work put to tender. Five percent shall have to be paid at the time of signing the agreement in the form of DCR/DD/Banker Cheque issued by a nationalized bank and the balance five percent shall be deducted from the bills.
10. No advance payment in the form of mobilization charges will be made to the successful tender bidder.

11. The successful tender bidder should tie up with reputed consultant dealing with civil construction project during the entire period of contract and the acknowledgement should be furnished by the consultant with commitment to provide all technical support as desired by the department, without which agreement shall not be drawn.
12. Bidders with pending works in hand where the progress is not satisfactory shall summarily be rejected.
13. Preference shall be given to firm with sound track records.
14. Eligibility to participate in the tender process shall be governed as per Gazette Notification of "The Arunachal Pradesh District Based Entrepreneurs and Professionals (Incentives, Development and Promotional) Act`2015.
15. Further, intending tenderer have to submit ST certificate, issued by competent authority, as proof of domicile of 16th Yachuli Assembly Constituency.
16. Black listed firms and Construction Company against whom black listing is contemplated need not apply.
17. The contractor shall not be paid extra amount for site development at construction site.
18. The undersigned reserves the right to reject the lowest tender, if quoted rates are found abnormally unjustified.
19. No Engineers of gazetted rank or other Gazetted officer employed in Engineering or administrative duties in an engineering department of the state/central government is allowed to work as a contractor for a period of two years after his retirement from government service, without permission from the government. This contract is liable to be cancelled if either the contractor or any of his employees is found at any time to be such a person who had not obtained the permission of the government as aforesaid before submission of the tender or engagement in the contractor's service.
20. The firm should be able to complete the project within 2(Two) months time from the date of commencement of the work.
21. To maintained the quality, material like Cement, MS Rod etc shall be issued by the Department which will be later recovered from the bill.
22. Registered contractor domicile of 16th Yachuli Assembly Constituency are eligible to collect tender Paper.
23. Any firm not fulfilling the above conditions need not apply.
