

The Technical Bids shall be opened on above mentioned date and time in the office of the Executive Engineer, PHE & WS Division, Aalo and evaluated to assess the technical viability, capability, etc and then only the price bid of the qualified tenders shall be opened for further evaluation. If the office happens to be closed on the date of opening of bids as specified above, the bids will be opened on next working day at same time and venue.
