1. **Eligibility Criteria:** As per Government of Arunachal Pradesh Notification no. 94, vol XXII, Naharlagun, Monday, April 13, 2015, THE ARUNACHAL PRADESH DISTRICT BASED ENTERPRENEURS AND PROFESSIONALS (INCENTIVES DEVELOPMENT AND PROMOTIONAL) ACT NO. 05 OF 2015, only registered contractors of appropriate class/categories domiciled within the territorial jurisdiction of Community Block under 33 Mechukha (ST) Assembly Constituency, where the Work Site is located are eligible to participate in the Tender process.
