- The Tender shall be submitted in two bids i.e., Technical Bids and Price Bids and each of bids shall be placed and sealed properly in two separate covers for each of the above works and mailed by registered AD post or by in person, so as to reach to the undersigned within **1000 Hrs of 18th February'2026**. The authority inviting tender will not be held responsible for the delay if any, in the delivery of the documents or non- receipt of the same in time.
- The Technical Bids shall be open on **1100 Hrs of 18th February'2026** in the office of Executive Engineer, PHE & WS Division, Mechukha and evaluate to assess the technical viability, capacity etc and then only the price bid of the qualified tenders shall be opened for further evaluation. If the

office happens to be closed on the date of opening of bids as specified above, the bid will be opened on next working day at the same time.

- 7. All other terms and conditions are given in the Tender Documents.


