## 1. The Project Area

Basar is a census town and the headquarters of Leparada District in Arunachal Pradesh. It is one of the oldest town in the State. The "Galos" are the predominant tribe in Basar township who belong to the mongoloid race of Indo-Tibetan stock. Basar township boasts of many streams, lush green valleys, sprawling forest area making it one of the most serene in the entire state. It acts as the gateway for tourist attractions like Mehchuka, Aalo, Tato etc. Beside the urban population, Basar township also hosts the ITBP by acting as one of the largest transit camps for paraforce. Due to the development of road connectivity in the recent years, Basar township has upgraded itself into a major business hub of the state. ## 4. <u>Need for Augmentation</u>

Water is currently supplied to Lower Basar township from Pagi, Hide and Heere sources at a rate of 0.92 MLD during the leanest period. The current population including the floating population of the Lower town and its peripheral settlement is around 4279 Nos. The demand of the town and nearby villages considering domestic demand and institutional demand of schools, offices, hospitals and other establishments, is likely to shoot up to 2.52 MLD at the end of the design period of 30 years. Hence, the deficit likely to be faced by the town and nearby area. at the end of the design period considered in this estimate is around 1.60 MLD if no augmentation program is undertaken. The existing distribution network has also outlived its design period and is inadequate to supply water at a required rate thereby reducing the already insufficient water availability in the water treatment plant. The existing treatment system is also based on old conventional methods which are proving to be incapable to treat water with high turbidity during monsoon season. Further, the current source from which water is tapped for Basar Township and nearby area is depleting rapidly and the discharge of the source depletes to such a level during lean period that water availability becomes an issue in many pockets of Lower Basar township and its peripheral settlements. Taking into consideration of all the above-mentioned issues, this scheme has been proposed to address the water scarcity in Lower area of Basar town and nearby villages

## 5. Existing Water Supply System

Existing water supply to Lower portion of Basar township is being supplied from Bur Abu stream which was executed many years back. The present water supply system has outlived its design period. The G.I. pipe main line and distribution network are in dilapidated condition.

### 6. <u>Baseline information in terms of population.</u>

The Present population of Lower Basar town and peripheral settlement is 4279 Nos. The project under consideration takes into account initial period as 2021, intermediate as 2035 and the ultimate period as 2052. Population forecasting was arrived at by using the the decadal growth rate of the state which is 26%. The population forecast is based on the base line survey of 2019 conducted by the Deptt. Of Urban Development and Housing endorsed by the District Administration. The survey was conducted by PHE Department by engaging self-help groups.

## 7. <u>Climatic Condition</u>

The average altitude of Lower Basar town is 615 meter above MSL. It has humid sub- tropical monsoon climatic. The annual rainfall is 4250 mm (approximate). The precipitation follows the monsoon pattern. The rain bearing monsoon winds bring about 80% of the rainfall. The temperature of Basar is moderate and varies from 4° C to 38°C.
