- Eligibility Criteria:-** As per the Government of Arunachal Pradesh notification No 94, Vol. XXII, Naharlagun, Monday, April 13/2015 THE ARUNACHAL PRADESH DISTRICT BASED ENTREPRENEURS AND PROFESSIONALS (INCENTIVES DEVELOPMENT AND PROFESSIONAL) ACT NO. 05 OF 2015, only registered contractors in Class III&II, domiciled within the territorial jurisdiction of 29 Basar ST Assembly Constituency are eligible to participate in the tender process issued on 16th Jan 2023 may be read as only the registered contractor in class-III & II categories of adjacent block/Assembly Constituency shall be eligible for participating in the tender as per the clause 4 (ii)(f) of the Arunachal Pradesh Entrepreneurship Act 2015
- The tender shall be submitted in two bids i.e. Technical Bids and Price Bids and each of bids shall be placed and sealed properly in two separate cover for each of the above works and submitted in person to the under signed within 27/01/2023 upto 10.00 A.M. The authority inviting tender will not be held responsible for the delay if any, in the delivery of the documents or non-receipt of the same in time.
- The intending bidders have to submit PRC and ST Certificate issued by the competent authority as proof of Domicile within the territorial jurisdiction of 29 Basar ST Assembly Constituency are eligible to participate in the tender process.
- Tender papers will be issued to contractor in between 16/01/2023 to 23/01/2023 up to 4.00 P.M. on payment of Rs 1500.00 (Rupees one thousand five hundred) only in cash/Demand draft (non-refundable), payable to the undersigned at SBI Basar and on production of valid contractor registration certificate.
- No tender documents shall be issued to the contractor after stipulated date and time.

The bids must be accompanied with earnest money of amount mentioned in Column No. 5 above against the tender package in the form of FDR/DD/DCR of any Bank (SBI/ APRB/ A.P Co-operative Apex Bank, Canara Bank etc.) issued in favour of the Executive Engineer PHE & WS Division, Basar in a separate envelope mentioned as "Earnest Money" on it along with the tender. The technical bids shall be first opened in the Office of the Executive Engineer, PHE&WS Division, Basar on 27/01/2023 at 11:00 A.M. in presence of the intending contractors or their authorised representatives and will be evaluated to assess the technical viability, capability, work experience and the financial capability of the contractors/firms and then only the financial bid of the qualified contractors/firms shall be opened after approval of the technical bid by the competent authority. The technical & financial bids will be evaluated by screening committee whose decision shall be final. If the office happens to be closed on the date of opening of bids as specified above, the bids shall be opened on next working day at the same time and venue.
8. In the event of non-opening of tender on specified date and time due to unavoidable circumstances, the undersigned shall notify a new date and time in the office notice board or through local newspapers.
