- Eligibility Criteria:-** As per the Government of Arunachal Pradesh notification No.94, Vol. XXII, Naharlagun, Monday, April 13/2015 THE ARUNACHAL PRADESH DISTRICT BASED ENTERPRENEURS AND PROFESSIONALS (INCENTIVES DEVELOPMENT AND PROFESSIONAL) ACT NO. 05 OF 2015, only registered contractors in Class IV and V, domiciled within the territorial jurisdiction of Dari Block under 29 Basar ST Assembly Constituency are eligible to participate in the tender process.
- The intending bidders have to submit PRC and ST Certificate issued by the competent authority as proof of Domicile within the territorial jurisdiction of Daring Block.
- Tender papers will be issued to contractor in between 28<sup>th</sup> December 2022 to 5<sup>th</sup> January 2023 up to 1600 hours, on payment of Rs.1500 (Rupees one thousand and five hundred) only in cash/Demand draft (non-refundable), payable to the undersigned at SBI Basar and on production of valid contractor registration certificate.
- No tender documents shall be issued to the contractor after stipulated date and time.
- The bids must be accompanied with earnest money of amount mentioned in Column No. 5 above against the tender package in the form of FDR/DD/DCR of any Bank (SBI/APRB/A.P Co-operative Apex Bank, Canara Bank etc.) issued in favour of the Executive Engineer PHE & WS Division Basar in a separate envelope mentioned as "Earnest Money" on it along with the tender. No other kind of deposit as earnest money will be accepted. Tender without earnest money will be summarily rejected.
- The technical bids shall be first opened in the Office of the Executive Engineer, PHE & WS Division Basar on 13<sup>th</sup> January 2023 at 1100 hours in presence of the intending contractors or their authorised representatives and will be evaluated to assess the technical viability, capability, work

experience and the financial capability of the contractors/firms and then only the financial bid of the qualified contractors/firms shall be opened after approval of the technical bid by the

competent authority. The technical & financial bids will be evaluated by screening committee whose decision shall be final. If the office happens to be closed on the date of opening of bids as specified above, the bids shall be opened on next working day at the same time and venue.

7. In the event of non-opening of tender on specified date and time due to unavoidable circumstances, the undersigned shall notify a new date and time in the office notice board or through local newspapers.
8. The undersigned reserves the right to reject any or all tender without assigning any reason.
