The authority inviting tender will not be held responsible for the delay if any, in the delivery of the document or non-receipt of the same on time. Technical Bids shall be opened on **30/06/2022 at 1030 Hrs** onward at office of Executive Engineer, PHE & WS Division Roing and evaluated to assess the technical viability, etc. and then only the price bid of the qualified tenderer shall be opened for further evaluation. If the office happens to be closed on the date of opening of bids as specified above, the bids will be opened on next working days at same time and venue.
2. The standard form of General Condition of Contract will not be issued along with the Tender Documents but the same shall form part of the agreement to be drawn and signed by both parties after acceptance of tender. The intending bidder must read the **General Condition of Contract 2020** or its latest edition carefully. He/she should only submit his/her bid if he/she agrees the terms and conditions laid therein.
3. Tender Documents can be obtained from the office of the undersigned from 21-06-2022 to 29-06-2022 on any working day in between 1000 hrs to 1600 hrs on payment of Rs 1500/- for Package No. I, IV, V, VII, VIII, IX, X, XI & XII and Rs. 2000/- for Package No. II, III, VI, XIII & XIV in cash. No tender paper shall be issued to contractor after the stipulated time.
4. The bidder must prepare EMD (1% for APST) in the form of FDR in favour of the Executive Engineer, PHE & WS Division, Roing issued by a Nationalized Bank/Scheduled Bank.
