The authority inviting tender will not be held responsible for the delay if any, in the delivery of the documents or non- receipt of the same in time.

The Technical Bids shall be first opened on 27<sup>th</sup> July'2022 at 10.00 am at the office of the Executive Engineer, PHE & WS Division, Hawaii in presence of intending tenderers or their authorized representatives and will be evaluated to assess the technical viability, capability, work experience and then only the financial bid of the qualified tenderer shall be opened after the approval of technical bid by the competent authority. The technical & financial bids will be evaluated by standing screening committee whose decision shall be final.
5. On the event of non-opening of tender on the specified date & time, the undersigned shall notify new date and time in the office Notice board.
6. Earnest money amounting in the form of DCR of any schedule Bank guaranteed by the reserve Bank of India/Bankers cheque of a scheduled bank/Demand draft must accompany each tender.


