**NOTICE INVITING TENDER**

The Executive Engineer, PHE & Water Supply Division Hawaii on behalf of Governor of Arunachal Pradesh invites sealed item rate tender from the eligible and approved contractors registered with PHED/PWD/RWD/WRD/UD/NEEPCO/NBCC/NHPC/BRO/MES/CPWD etc. up to 1000 Hrs on 26/03/2023 for execution of the following below mentioned works.

- i) The Tender will be opened on 26/03/2023 at 10000 hours. If the office happens to be closed on the fixed date of opening, the tender will be opened on next day at the same time and venue.
1. The Tender shall be submitted in two bid i.e.(i) Technical Bids (ii) Price Bids, each of bids shall be placed and sealed in proper separate cover for each works and mailed by registered AD post/by in person, so as to reach to the undersigned within 0900hrs Hrs of 26/03/2023. The authority inviting tender will not be held responsible for the delay if any, in the delivery of the documents or non-receipt of the same in time.
2. The Tender bidder should prepare the technical bid after visiting the actual sites of construction for which they have to contact the Assistant Engineer, PHE & WS Sub-Division, Hayuliang before collection of tender paper. They should also visit the office of the Assistant Engineer, PHE & WS Sub-Division, Hayuliang to see the drawing of various components of works.
3. The Technical Bid shall be opened first and evaluated to assess the Technical and financial capacity of the contractor/firms and their work experience by the competent authority. Based on such evaluation and after adopting the post qualification procedure, the price bid containing only the schedule of quantities (As per PWD-8) shall be opened for further evaluation by higher competent authority.
