- 4 The Technical Bids shall be first opened on 26th July/2022 at 1300 Hrs. at the office of the Executive Engineer, PHE & WS Division, Hawai in presence of intending tenderers or their authorised representatives and will be evaluated to assess the technical viability, capability, work experience and then only the financial bid of the qualified tenderer shall be opened after the approval of technical bid by the competent authority. The technical & financial bids will be evaluated by standing screening committee whose decision shall be final.
- 5 On the event of non-opening of tender on the specified date & time, the undersigned shall notify new date and time in the office Notice Board.


