2 Tender documents can be obtained from the office of the Executive Engineer, PHE & WS Division, Hawaii, Anjaw District, Arunachal Pradesh on all working days from 20th January/2023 to upto 4.00 p.m. of 24th January/2023, on payment of cost of Tender paper of Rs. 1500/- in cash/Demand draft (non-refundable) payable to undersigned at SBI, Hawaii and on production of valid contractor registration certificate.

3 The Tender shall be submitted in two bid i.e. Technical Bids and Price Bids and each of bids shall be placed and sealed in properly in two separate cover for each of the above works and mailed by registered AD post by in person, so as to reach to the undersigned before or within 1600 hrs of 24th January/2023. The authority inviting tender will not be held responsible for the delay if any, in the delivery of the documents or non-receipt of the same in time.

4 The Technical Bids shall be first opened on 25th January/2023 at 1000 Hrs. followed by financial bid at the office of the Executive Engineer, PHE & WS Division, Hawaii in presence of intending tenderers or their authorised representatives and will be evaluated to assess the technical viability, capability, work experience and then only the financial bid of the qualified tenderer shall be opened after the approval of technical bid by the competent authority. The technical & financial bids will be evaluated by standing screening committee whose decision shall be final.
