Criteria of eligibility for bidders: -

- A) Work experience- The bidder should have satisfactorily completed the works as mentioned below during the last 7 (seven) years ending previously day of last date of submission of tenders.
 - a) 3 (three) similar works each of value not less than Rs.3,43,26,996/- (40% of estimated cost put to tender ECPT) or 2 (two) similar works each of value not less than Rs.5,14,90,495/- (60% of ECPT) or 1 (one) similar work of value not less than Rs.6,86,53,993/- (80% of estimated cost)
 - b) One completed work of any nature (either part of (a) above or separate one costing not less than the amount equal to Rs.3,43,26,996/- (40% of ECPT) with any of Central/ State Government Department / Central Autonomous Body / State Autonomous body / Central Public sector/Undertaking/ State Public Sector Undertaking / City Development Authority/Municipal Corporation of City.

[Any work experience completed on Sub-Contractor/ Back-to-Back Sub Contract Basis shall not be considered for Pre-Qualification eligibility for the tender]

2. The bidder should have had minimum, average annual financial turn-over (gross) of not less than Rs.4,29,08,746/- (50% of ECPT) on civil construction works during the last

available Seven years balance sheets duly audited by Chartered Accountant.

- 3. The bidder should not have incurred any loss in more than two years during available last five years consecutive balance sheet, duly audited and certified by the Chartered Accountant.
- 4. The bidding capacity of bidder shall be equal to or more than the ECPT of Rs. 8,58,17,491/- (Eight Crores Fifty Eight Lakhs Seventeen Thousand Four Hundred & Ninety One) only.
- 5. The bidder shall submit a minimum solvency of Rs.3,43,26,996/- (Rupees Three Crores Fourty Three Lakhs Twenty Six thousand Nine hundred Ninety Six only) certified by his Bankers. [40% of ECPT].

OR

The bidder shall submit existing Credit facility From Bankers for Rs.3,43,26,996/-(Rupees Three Crores Fourty Three Lakhs Twenty Six thousand Nine hundred Ninety Six only) certified by his Bankers. [40% of ECPT].

- 6. The bidder shall submit an affidavit to invest cash up to Rs.2,14,54,373/- (Rupees Two Crores Fourteen Lakhs Fifty four thousand Three Hundred Seventy Three) Only (25% of ECPT).
- 7. Intending Bidder must not be placed in the Negative List of firms of any department/ organization
- 8. The bidder is required to submit design for the project as part of the bidding process.

B) Enlistment status-

- (i) Bidder should be enlisted with any of the Enlistment Authority & shall be governed in accordance with provisions as per Arunachal Pradesh District Based Entrepreneurs and Professionals Incentives. Development & Promotional) Act of 2020 vide Notification No. Law/Legn-23/2020 Dtd. 02/11/2020 as under:
 - a) Class I Civil category enlisted contractors/firms under Arunachal Pradesh Public Works Department (APPWD), or
 - b) Equivalent class/category registered with other Govt/Autonomous organizations (State PWD, CPWD, BRO, NHAI, NHIDCL etc.) involved in development of Infrastructure projects.
 - c) The bidders registered under Company Act must be mandatorily enlisted in any works department under Central/State Govt. or any Autonomous Organization.
- (ii) Joint Ventures (JV) are not allowed.
- (iii) PoA (Power of Attorney) Holders representing any firm/entity are barred from participating in this NIT. Only Proprietor or Managing Director of Firm/Company/Partners/Partners of partnership firm are eligible.
- (iv) The enlistment/registration of the firm must be valid on the schedule date of opening of Technical Bid prescribed in IFB.
- (v) Intending Bidder must not be placed in the Negative List of firms of any department/organization for any reason including failure abandoning the project without permission of the department/organization, unethical practices, failure to abide by Integrity Pact or failure to follow any lawful directions given by the department/organization.

 A Bidder, whose proprietor/partner/director/organization is having any F.I.R./police case going on due to corrupt or unethical practices during tenders/execution of contracts, or is/was barred from participating in the tenders/during execution of contract in any Central/State Govt. organization or Central/State Public Sector Units (PSU) or Autonomous bodies or Public Listed Company or Private Limited Company Govt or PSU Work Agency, such will not be allowed to participate in the tender process- A bidder will have to submit an affidavit incompliance to this clause. A general practice Format of Affidavit has to be submitted and it has to be notarized.

Non-fulfilments of any eligibility criteria under Clause 1 to Clause 8 of IFB may lead to 9. disqualification and bids liable to be summarily rejected.

In the event of the confusion or misinterpretation arising out of the tender documents and 10. without prejudice to any of the bidders, the interpretation of the author of the documents shall prevail without overriding statutory orders of the GoAP/CVC guidelines/GFR-2017 and CPWD manuals 2024.

11. Cost escalation will not be permitted, and no additional payment will be made to the contractor until the project is completed, as per the specified bid amount.

12. For other details - Please refer to bid documents.

Special Conditions: -

- The Firm must have adequate manpower of technical expertise and necessary infrastructure to handle such projects (for details of manpower, T&P, please refer bid documents.
- Cost Escalation will not be permitted, and no additional payment will be made to the 2. contractor until the project is completed, as per the specified bid amount.

The Firm should be able to complete the work within stipulated time of 12 (Twelve) 3. months from the date of commencement of work.

The Firm must submit latest Income Tax clearance/Return certificate. 4.

- 5. (a) The successful bidder shall have to pay performance Guarantee deposit amounting to 5% of the cost of work put to tender within 7 (seven) days from the date of signing of agreement. For extension of time for submission of Performance Guarantee beyond stipulated time period in NIT, the NIT approving Authority may include provision of extension of time at the interest rate of 1% per day of tender value. but such extension should not exceed by another 7 (seven) days. However, in case the last day of submission of PG happens to be a Bank holiday. the last day of submission shall be a next working day, failing which the successful bidder shall be treated cancelled and automatically the second successful bidder shall be awarded the tender work at the rate approved for L I if the Firm agrees. The performance Guarantee shall remain valid for a period of six months beyond the date of completion of all contractual works.
 - (b) In order to ensure assured quality, the successful bidder shall procure all cement, steel & other construction materials from the Govt. of Arunachal Pradesh approved manufacturer or firm only.
- 6. No advance payment in the form of mobilization charges shall be made to the successful tenderer.
- 7. Authorized Engineer: The Executive Engineer PHE &WS Division, Namsai will be the Engineerin-charge of the project, who will discharge the functions and duties specified during project. The bidders before collection of Tender paper shall mandatorily visit the site and also the joint inspection certificate of the sites dully signed by the Assistant Engineer to be submitted.

8. Any disputes arising related to the work shall be settled by the contractor at their own cost and expense.

The rate quoted by the tenderer shall include all taxes including GST, transportation and FOR at site etc.

- 10. Contractor shall have to pay Royalty and monopoly fees for the collection of minerals/mines and forest produce at the rate prescribed by the Department of Forest, Mines & Minerals, Government of Arunachal Pradesh and all such charges shall be deemed to have covered in the rate quoted by the Contractor. No extra claim on account of such payment shall be entellained during the currency of the Contract. If not paid then the royalty amount shall be deducted from the bill.
- 11. Disputes outside the provision of contract: The contractor shall be responsible to make settlement of Local disputes, if arising between the contractor or his workmen or local people or any related issues. However, such resolution should not affect outcome of the project in terms of quality specification or the time limit.

12. The tenderer should submit NOC from the state Co-operative Apex Bank of Arunachal Pradesh in original at the time of applying bidding document.
