(Non-Refundable) **in favour of the Executive Engineer, PHE & WS Division, Changlang** payable at State Bank of India, Changlang Branch, Changlang. Further, if the Office happens to be closed on the date of the opening of the tenders as specified, the bids will be opened on the next working day at the same time and venue.
4. **Other detailed Special Terms & Conditions can be seen in the bidding documents (Technical Bid).**

The Bidders should be registered Contractors in Class-IV & III categories domiciled within the territorial Jurisdiction of Assembly Constituency as per the “**Arunachal Pradesh District based Entrepreneurs and Professionals (Incentives, Development and Promotional) Act’2015 & Amendment Act’2020**” and Biding limit of the contractors shall be governed as per the Arunachal Pradesh Enlistment of Contractor in Works Department Rules 2008 and latest Amendment made by the Govt. of Arunachal Pradesh from time to time.
