(Non-Refundable) **in favour of the Executive Engineer, PHE & WS Division, Changlang** payable at State Bank of India, Changlang Branch, Changlang. Further, if the Office happens to be closed on the date of the opening of the tenders as specified, the bids will be opened on the next working day at the same time and venue.

The Bidders should be registered Contractors in Class-V to V(A) categories domiciled within the territorial Jurisdiction of respective Community Block as per the “**Arunachal Pradesh District based Entrepreneurs and Professionals (Incentives, Development and Promotional) Act’2015 & Ammendment Act’2020**” and Biding limit of the contractors shall be governed as per the Arunachal Pradesh Enlistment of Contractor in Works Department Rules 2008 and latest Amendment made by the Govt. of Arunachal Pradesh from time to time.

The General Condition of Contract booklet will not be issued along with the Tender Documents but the same shall form Part of the Agreement to be drawn and Signed by both the parties after acceptance of Tender. The intending Bidder must read the General Conditions of Contract -2014 or its latest edition. He/She should only submit their Bid if he/she agrees the terms and conditions.
