NOTICE INVITING TENDER

The Chief Engineer (E/Z), PHE & Water Supply Department , Namsai, on behalf of Governor of Arunachal Pradesh invites sealed bids from eligible registered contractor on Turnkey contract basis, for the following work under NESIDS funding:

- 1 The tender paper can be collected from the office of the Executive Engineer, PHE& WS Division, Khonsa, Tirap District on all working day in between 1000 hrs to 1600 hrs from **09/ 08/ 2022 to 20/ 08/ 2022** on payment of **Rs 5,000/-** (Rupees Five Thousand) only either in cash or in the shape of D.D. (Non refundable) in favour of the Executive Engineer, PHE & WS Division, payable at State Bank of India, Khonsa.
- 2 The Tender shall be submitted in three envelope system /bids viz. (i) Documents related to Eligibility Criteria (ii) Technical bid & (iii) Financial / Price bid. Each of the bids shall be placed and sealed in separate cover addressed to Executive Engineer, PHE&WS Division Khonsa and these three separate sealed bids should be further sealed in a single envelope and mailed by registered post/by person so as to reach on or before the stipulated date & time **(22/ 08/ 2022 upto 1030 hrs.)**. The authority inviting tender will not be responsible for delay if any, on submission/ receipt of bids.
- 3 Documents related to Eligibility criteria shall be opened first on **22nd August 2022 at 1100 Hrs** at the **Office of the Executive Engineer, PHE & WS Division, Khonsa** . The Technical bids of tenderers who satisfy the Eligibility criteria shall then be opened at notified time, date and place in presence of tenderers or their representatives. After finalization of Technical bid, the Financial/Price bids shall be opened on next fixed date and time.
- 4 On the event of non opening of tender on the specified date & time due to unavoidable circumstances, the undersigned reserves the right to notify a new date and time in the notice board of Office and website of the department.
- 5 All other terms and conditions are given in the Tender Document.



SPECIAL TERMS & CONDITION

- 1 Tender Documents can be obtained from the office of the Executive Engineer, PHE & WS Division Khonsa, Tirap District, Arunachal Pradesh on all Working days within **the date and time as given in the List of Important dates** on payment of cost of Tender paper of Rs 5000/- in cash/ Demand draft (Non refundable) payable to undersigned at SBI Khonsa and on production of valid contractor registration certificate of appropriate class.
- 2 The Registered Contractor falling under the categories of Class-IA issued by Central/State Agencies may apply. However the onus of proving the credentials of such registration applies to the concerned firm. The department shall verify the authenticity of such registration.
- 3 The interested firm willing to submit tender must have successfully executed civil construction works in hilly area in the past three years ending on the last day of the month previous to the one in which the tenders are invited.
 - a. Three similar works each of value not less than 40% of estimated cost put to tender (Rs. 15,78,47,600.00)
or
 - b. Two similar works each of value not less than 60 % of ECPT (Rs. 23,67,71,400.00)
or
 - c. One similar work of value not less than 80% of ECPT (Rs. 31,56,95,200.00)

Similar works shall mean experience in construction of building of amount defined in bid with provision of standalone water treatment system ,water tank , Sewerage lines with treatment system, along with experience of construction of roads & buildings.

- 4 Experience of such work execution must be substantiated with a performance report of completed projects duly certified by the project officer. Such performance report must have the details like date of commencement and date of completion.
- 5 Earnest money @ Rs 20,00,000.00 plus 1% of the estimated cost in excess of Rs Ten crores amounting to Rs. 49,46,190.00 (Rupees Forty nine lakh forty six thousand one hundred ninety) only for general Non APST and @ 1% for APST Rs. 39,46,190.00 (Rupees Thirty nine lakhs forty six thousand one hundred ninety) only, in the appropriate form of any scheduled bank guaranteed by the Reserved Bank of India must accompany each tender with validity to the extent of bid/tender period, failing which the tender will be summarily rejected.
- 6 The earnest money is accepted only in the form of Treasury challan (form TR6/GAR in duplicate)/ DCR/ Bankers Cheque /Demand Draft/ FDR issued by a Scheduled/nationalized bank in favour of Executive Engineer , PHE&WS Division , khonsa.
- 7 The bidder must have annual financial turnover on construction works of at least Rs.19,73,09,500.00 (which is 50% of the estimated cost put to tender) during the immediate last three consecutive financial years duly audited and certified by the Chartered Accountant.
- 8 The bidder should not have incurred any loss (profit after tax should be positive) in more than two years during available last five consecutive balance sheet, duly audited and certified by the Chartered Accountant.
- 9 The contractor should have solvency of Rs. 15,78,47,600.00 (40% of estimated cost put on tender) certified by his banker.(copy of original solvency certificate to be attached).
- 10 Any firm whom a similar nature of work was awarded in the last three years and could not complete within scheduled time without justified reason authenticated by the project authority need not apply.
- 11 The firm must have adequate manpower of technical expertise ,necessary infrastructure and equipments to handle such projects as per The Arunachal Pradesh Gazette No.20, Vol XXIX, Naharlagun, Wednesday, October 31, 2018 Kartika 9, 1940 (Saka).

- The firm must have sound financial background to complete the project even in the eventuality of unavoidable delay in payment owing to such reason as financial crunch of the client department/government. No interest will however be paid for the delay in payment.
- 12 The firm should be able to complete the project within **24 (Twenty four) months time** from the date of commencement of work.
 - 13 The firm must submit latest Income Tax clearance/tax return certificate till 31-03-2022 at the time of submission of tender. If tax is exempted, then the firm has to produce tax exemption certification issued from the competent authority.
 - 14 The firm shall not form any joint venture or enter into association for bidding of tender.
 - 15 The selected firm on acceptance of tender shall have to pay security deposit amounting to 10 (Ten) percent of the cost of work put to tender. Five percent shall have to be paid at the time of signing the agreement in the form of DCR/ Bankers Cheque /Demand Draft/ FDR issued by a Scheduled/ nationalized bank in favour of Executive Engineer , PHE & WS Division , Khonsa or Government Securities or an irrevocable Bank Guarantee Bond of State Bank of India or any scheduled bank and the balance five percent shall be deducted from the first stage bill payment.
 - 16 The successful bidder shall have to pay Performance Guarantee deposit amounting to 3 (Three) percent of the cost of work put to tender within 15 (fifteen) days from the date of signing of agreement. For extension of time for submission of Performance Guarantee beyond stipulated time period in NIT , the NIT approving authorities may include provision of extension of time at interest rate of 1% per day of tender value , but such extension should not exceed by another 7 (Seven) days. However in case last day of submission of Performance Guarantee happens to be a bank holiday, the last day of submission shall be the next working day. Failing of which the successful bidder shall be treated cancelled and automatically the second successful bidder shall be awarded the tender work at the rate approved for L₁ if the firm agrees.
 - 17 The Performance Guarantee shall remain valid for a minimum period of sixty days beyond the date of completion of all contractual work.
 - 18 No advance payment in the form of mobilization charges will be made to the successful bidder.
 - 19 The bidder should tie up with a certified consultant/consultancy firm with expertise in water works and Sewerage project having completed similar project amounting to atleast 50% of the bid value during last three years. The contractor shall also furnish an undertaking from the consultant with commitment to provide all technical support as desired by the department during entirety of the contract.
 - 20 Bidders with pending works in hand where the progress is not satisfactory shall summarily be rejected.
 - 21 The successful bidder has to submit the basic as well as **detailed hydraulic and structural design of all components** as described the technical specifications and distribution network design using latest software.
 - 22 Black listed firms and Construction Company against whom black listing is contemplated need not apply.
 - 23 The tender bidder should prepare the technical bid after visiting the actual sites of construction for which they have to contact the **Assistant Engineer, PHE& WS Sub Division, Deomali** before collection of tender paper.
 - 24 Execution of works should be done as per the detailed project report and in case of reduction of work scope in due course of implementation, as per the actual site conditions, if any, no payment shall be claimed for the unexecuted work or such reduced or deleted component.




- 25 The firm must submit the latest GST return file and GST Registration Certificate.
- 26 The firm must obtain authorization/NOC letter from the land owner for the requisite land not less than 2000 sqms technically selected/feasible by the department.
- 27 The bidder must submit the EPF registration certificate with latest payment challan.
- 28 The firm must not have more than 3(three) works in hand in any of the departments under Government of Arunachal Pradesh at a time and for which the firm must make a declaration to be executed in an Affidavit that the firm is not engaged in more than four any tender works under the State Govt.
- 29 The Tenderer should submit NOC from the state Co-operative Apex Bank of Arunachal Pradesh in original at the time of applying bidding document. The NOC should have been issued after 01.08.2022.
- 30 The work site fall within the Inner Line area demarcation of Government of India and the contractor residing outside the Inner Line Area shall have to obtain Inner Line Permit for entering the area/work site for himself as well as for the workers being brought from outside the Inner Line demarcation from designate officers for issue of Inner line permit by Government of Arunachal Pradesh. For the same purpose the contractor may contact the Resident Commissioner, Government of Arunachal Pradesh at New Delhi Arunachal Bhawan for the Deputy Resident Commissioner, Arunachal Bhawan Kolkata, Guwahati, Shillong of the Assistant Director Supply and Transport, Government of Arunachal Pradesh Mohanbari. He shall have to pay the prescribed fees fixed by Government of A.P. payable for issue of the Inner Line Permit by competent authority for which no extra claim shall be entertained.
- 31 The competent authority on behalf of the Governor of Arunachal Pradesh does not bind itself to accept the lowest or any other tender and reserves to itself the authority to reject any or all the tenders received without the assignment of any reason. All tenders in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the tenderer shall be summarily rejected.
- 32 Canvassing whether directly or indirectly, in connection with tenders is strictly prohibited and the tenders submitted by the contractors who resort to canvassing will be liable to rejection.
- 33 Any firm not fulfilling above conditions need not apply. Apart from above, all documentary evidence/terms and conditions etc. in support of the order of the firm may be included/indicated.
- 34 The required land shall be arranged by the bidders and necessary land availability certificate must be submitted, along with bids document.
