and then packed together in a single cover with proper sealing and clearly mentioning the name of work and NIT No, and address and can be mailed by registered post so as to reach the undersigned or may be dropped in the Tender Box available in the office of the undersigned on or before the stipulated date and time. The authority inviting tender will not be held responsible for the delay if any, in the delivery of the document or non-receipt of the same on time. Technical Bid shall be opened on 26/11/2022 at 1100hrs onward at office of Executive Engineer, PHE & WS Division Longding and evaluated to assess the technical viability, etc. and then only the price bid of the qualified tenderer shall be opened for further evaluation. If the office happens to be closed on the date of opening of bids as specified above, the bid will be opened on next working days at same time and venue.

- 2. The bidder must prepare EMD (1% for APST & 2% for Non-APST) in the form of DCR/DD/FDR in favour of the Executive Engineer, PHE & WS Division, Longding issued by a Nationalized/Scheduled Bank.
- 3. The Design and technical specification of various components as furnish by the successful bidder shall be examined and approved by the competent authority before implementation in the field.
- 4. The interested firms willing to submit the tender must have successfully executed:
- i) Three similar works each costing not less than 40% of the estimated cost.
- ii) Two similar work each costing not less than 60% of estimated cost.
- iii) One similar works costing not less than 80% of estimated cost.

Experience of such work execution must be substantiated with a performance report of completed project duty certified by the project office not below the rank Executive Engineer/CEO of Municipal Corporation. Such performance report must have the detail like, date of commencement and date of completion.

- 5. The standard form of General Condition of Contract will not be issued along with the tender documents but the same shall form part of the agreement to be drawn and signed by both parties after acceptance of tender. The intending bidder must read the **General Condition of contract 2022** or its latest edition carefully. He/she should only submit his/her bid if he/she agrees the terms and conditions laid therein.
- 6. Tender documents can be obtained from the office of the undersigned on any working day in between 1000 hrs to 1600 hrs on payment of Rs 1000/- (Rupees One thousand) only in each. No tender paper shall be issued to contractor after the stipulated time.
- 7. Other special terms and conditions can be seen in the bidding documents.

8. ELIGIBILITY CRITERIA

- i) A Bidder has to have a registered company in India under companies' act of India before awarding the project as per companies' act of 2013.
- ii) The Bidder shall meet the technical and financial criteria required for qualifying.
- iii) The Bidder shall have manufacturer/dealership authorization form from the manufacturers of Zincalume tank as per specification in tender.

9) QUALIFYING CRITERIA

- i) The audit financial statement for last three (3) Years shall be submitted
- ii) The bidder shall have an average annual turnover not less than 50% of estimated cost put to tender.
- iii) The bidder shall demonstrate that it has successful experience in the substantial completion of at least 1 (One) similar water supply project.
- 10 No tender paper shall be issued to contractor without the above eligibility criteria condition.
