Based on such evaluation, the Price Bid of qualified tenderers shall be opened for further evaluation by the tender board after approval from the competent authority of PHE & WS Department, Arunachal Pradesh. The technical and financial bid will be evaluated by board members whose decision shall be final and binding.

- 7 The undersigned reserves the "**Right to reject all the tenders without assigning any reason**".


