Terms and Conditions:

1. The firm/ bidder participating in the tender must be domiciled within the territorial jurisdiction of Community, block/ assembly constituency under Tawang District, Arunachal Pradesh.
2. Tender document can be obtained from the office of the Assistant Engineer, PHE & WS Sub – Division Lumla in any working day in between 1000 hrs to 1600 hrs on payment of Rs. 500.00(five hundred) only in cash /shape of DD non-refundable drawn in favour of the undersigned payable at state bank of India Tawang branch. No bidding document shall be issued to the contractor after the stipulated time limit.
3. The standard form of **General Condition of Contract** will not be issued along with the Tender document but the same shall be formed part of the agreement to be drawn and signed by both the parties after acceptance of the Tender. The intending bidder must read the **General Condition of Contract 2019** or its latest edition carefully. He should only submit his bid if he agrees the terms and conditions laid therein.
4. The bidders are required to visit sites to examine and familiarize themselves with concerned site of works at their own cost, responsibility and risk before submitting the bid. The firm may contact the Assistant Engineer in – charge of the project of the site of the work.
5. The tender shall be submitted in two bids viz. Technical Bid and Price Bid. Each of the bids shall be placed and sealed in separate cover and these two separate sealed bids should be further sealed in a single envelope and mailed by registered post so as to reach the office of the Assistant Engineer PHE&WSD Lumla or may be dropped in the tender box on or before 29.12.2021 up to 1000 hrs.
6. The Arunachal Pradesh District Based Entrepreneurs and Professionals (Intensives, Development and Promotional) (Amendment) Act, 2020 shall be applicable in this tender.
7. The Technical Bid shall be opened first and evaluated to assess the Technical and financial capability of the contractors/firms and their work experience. Based on such evaluation and after adopting the post qualification procedure, the price bid containing only the schedule of quantities (As per PWD-8) shall be opened for further evaluation.
8. Special conditions, other terms and conditions and technical details of the NIT may be seen at “Technical Bid”.
